

These reports were submitted to the Bureau of Tuberculosis Control in Harrisburg, Pa. Copies of five of these reports have been obtained. The reports have two basis sections: (1) a written section describing the activities of the staff and employees and (2) tables of statistical data concerning patient care and hospital operations. These reports are like time capsules giving us a glimpse into the people and activities at the sanatorium. As luck would have it, several of these reports were written in 1955 and 1956, the two years that I was a patient in the sanatorium and so I was there to witness some of these events .

Miscellaneous Staff Education
